## QUICK GUIDE TO USES OF THE ARTSTOR LIBRARY

### **Noncommercial Educational Uses Only**

You may only access and use the ARTstor Library, and any content in the Library, for educational and scholarly uses that are noncommercial in nature. Commercial uses are strictly prohibited.

### **Restricted Access**

The ARTstor Library is a licensed resource that is only made available to Authorized Users. Authorized Users are determined by your institution, and may include individuals officially or unofficially affiliated with the institution, or individuals physically present in the institution's facilities. For more information on Authorized Users, see your institutional representative.

You may not sublicense, or provide others with access to, the electronic database itself (such as by sharing your password).

Likewise, content from the ARTstor Library may not be made available (whether alone or incorporated into other materials), except to:

- your institution and Authorized Users;
- audience members at a scholarly or educational presentation, lecture, class, or similar activity that you are conducting (via displays and print hand outs only); or
- if you are using the ARTstor Library in the United States of America ("USA") only, limited numbers of scholars, researchers, or curators to whom work by an Authorized User that incorporates Content is made available for purposes of collaboration, comment, or similar educational or scholarly use, if such use conforms to the customary and usual practice in the field.

### **Use Outside of the United States of America**

If you are using the ARTstor Library outside of the USA, you may only use or display the ARTstor Library, or make electronic or print copies of Content appearing in the Library, within your institution's facilities for use therein (which include your institution's libraries, lecture halls, classrooms, off- or on-campus offices, and off- or on-campus dorm rooms or similar facilities).

### **Printing**

If you print images or other content from the ARTstor Library, you must use the designated print function provided in the ARTstor Library. A label indicating that the content may only be used for noncommercial uses will automatically appear alongside the images on such print copies. You may not

make available printed images or other content to others, except as set forth in the Restricted Access provisions above. If you are printing content from the ARTstor Library for use outside of the USA, you may only use such printed content in Your Institution's Facilities.

### **Exporting/Downloading**

If you export or download images or other content from the ARTstor Library, you must use one of the designated export functions provided in the ARTstor Library, and exported content must be access restricted. You may not make available exported images or other content to others, except as set forth in the Restricted Access provisions above. If you are exporting content from the ARTstor Library for use outside of the USA, you may only use such exported content in Your Institution's Facilities.

### **Access Software**

You may not copy, distribute, modify, decompile, reverse engineer, or create derivative works from the software provided to you to access the ARTstor Library.

## **EXAMPLES OF PERMITTED USES**

**Classroom Instruction and Related Activities** (such as handouts, presentations, research, and student assignments).

**Display or performance as part of a noncommercial scholarly or educational presentation** (such as in seminars, classes, lectures, conferences, exhibits, workshops, or similar noncommercial educational and scholarly activities).

**Student or faculty portfolios, term papers, theses, and dissertations**, provided that you follow the access restrictions stated on the previous page.

## **EXAMPLES OF PROHIBITED USES**

**Any commercial use and any use that is not educational or scholarly** (such as reproductions in alumni materials, in advertisements, or commercial materials, or making content available to someone else for commercial uses).

**Posting content on an unrestricted website or in other materials made available on the world wide web without access restrictions, or providing it to someone else who makes it available to the public.**

**Adopting, modifying, or making a derivative work from content in the ARTstor Library, or removing a copyright notice from content in the ARTstor Library.**
